**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO SMS GLOBAL TECHNOLOGIES, INC. DECLARING THE BIDDER WITH THE SINGLE RATED AND RESPONSIVE BID FOR THE PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND CONFIGURATION OF I.T. HARDWARE SERVER AND DESIGN AND DEVELOPMENT OF THE WEB-BASED CDA'S SYSTEM WITH CONTRACT NO. CDA-GOODS-2018-04**

**WHEREAS**, the **COOPERATIVE DEVELOPMENT AUTHORITY** through its **BIDS AND AWARDS COMMITTEE (BAC)** advertised/posted the Invitation to Bid through Public Bidding for the Project: **SUPPLY, DELIVERY, INSTALLATION AND CONFIGURATION OF I.T. HARDWARE SERVER AND DESIGN AND DEVELOPMENT OF THE WEB-BASED CDA'S SYSTEM** under Contract No. CDA-GOODS-2018-04 in the PhilGEPS and CDA Websites, Business World newspaper and conspicuous place at the CDA Central Office Bulletin Board, Main Lobby starting September 18, 2018 up to October 09, 2018 with an Approved Budget for The Contract in the amount of P5,300,000.00;

**WHEREAS**, in accordance with Section 23 of the Revised Implementing Rules and Regulations of Republic Act 9184, a Pre-Bid Conference was conducted on September 26, 2018, Wednesday, 2:00 P.M. held at the CDA Conference Room, Ground Floor, CDA Building, the CDA-BAC discussed the details of the requirements of the Public Bidding as indicated in the Bidding Documents;

**WHEREAS**, in response to the Invitation to Bid, two (2) Bidders purchased Bidding documents, namely: ITWORKS GLOBAL SOLUTIONS located at Unit 903-B West Tower Philippine Stock Exchange, Pasig City and SMS GLOBAL SOLUTIONS located at Penthouse, East Tower, Philippine Stock Exchange, Pasig City. However, only SMS GLOBAL TECHNOLOGIES, INC. submitted Bid documents before the scheduled deadline of submission October 09, 2018, Monday, at 1:30 P.M. and attended the Opening of Bids on October 09, 2018, Monday, at 2:00 P.M.;

**WHEREAS**, upon opening of bids and preliminary examination done by the Bids and Awards Committee, the SMS GLOBAL TECHNOLOGIES, Inc. was rated "Passed" by the BAC for their submitted Envelope No. 1 or compliant with the Technical Component;

**WHEREAS**, the Envelope No. 2 (Financial component) submitted by SMS GLOBAL TECHNOLOGIES, Inc. was opened and determined by the BAC compliant vis-à-vis the requirements particularly the Bid Price and the Bid Form as submitted, thus the result was read as follows;


