**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO SULHEN AND TJJ CORPORATION AND DECLARING THE BIDDER WITH THE SINGLE RATED AND RESPONSIVE BID FOR THE RE-BIDDING OF THE SUPPLY AND DELIVERY OF MOBILE MINI RICE MILL WITH DE-STONER (50 UNITS) UNDER THE MINDANAO PEACE AND NORMALIZATION THROUGH COOPERATIVE DEVELOPMENT WITH CONTRACT NO. **WHEREAS**, in accordance with Section 23 of the Revised Implementing Rules and Regulations of Republic Act 9184, a Pre-Bid Conference was conducted on June 18, 2018, Monday, 10:00 A.M. held at the CDA Conference Room, Ground Floor, CDA Building, the CDA-BAC discussed the details of the requirements of the Public Bidding as indicated in the Bidding Documents;

**WHEREAS**, in response to the Invitation to Bid, only one (1) Bidder, **SULHEN AND TJJ CORPORATION** with business address located at 142 A. Luna St., Malinao, Pasig City purchased the Bidding Documents and submitted Bidding documents during the scheduled deadline of submission and Opening of Bids on July 2, 2018, Monday, 2:00 P.M.;

**WHEREAS**, upon opening of bids and preliminary examination done by the Bids and Awards Committee, the Sulhen and TJJ Corporation was rated "Passed" by the BAC for their submitted Envelope No. 1 or compliant with the Technical Component;


