WHEREAS, the COOPERATIVE DEVELOPMENT AUTHORITY – Tuguegarao Extension Office through its **BIDS AND AWARDS COMMITTEE (BAC)** advertised and posted the Invitation to Bid for the Project: **Repair of the Damaged CDA-Tuguegarao Extension Office Building** in the PhilGEPS CDA Central Office Website, and in the conspicuous place of the CDA-Tuguegarao Extension Office Main Lobby starting September 11, 2018;

WHEREAS, in response to the said invitation, only **one (1) prospective Bidder/Contractor** purchased Bidding Documents from the BAC Secretariat of the CDA-Tuguegarao Extension Office, and participated in the Opening of Bids. The participating bidder/contractor is **CAVAT CAPITOL MERCHANDISING AND CONSTRUCTION** with business address located at Carig Norte, Tuguegarao City, Cagayan.



WHEREAS, the above-mentioned Bidder was rated "Passed" by the Bids and Awards Committee, having found to be compliant as to the eligibility and technical requirements, and its corresponding financial bid proposal as publicly read, also passed the preliminary examination and was found to be within the approved budget for the contract, as hereunder summarized as follows:
