	Having established the required quorum, DED Platero proceeded with the pre-bid conference proper.
a la	DED Platero requested the BAC secretariat to present the chronology of events regarding the instructions of the BOA on the posting/publication of the project.
	DED Platero also discussed the Agency's compliance to invite representatives from COA, Philippine Chamber of Commerce and Philippine Cooperative Center as Observers to the Pre-Bid Conference. Likewise, the BAC sent invitations to AMTEC, DA and PhilMech to attend the procurement activities.

BID DATA SHEET	Upon motion of Atty. Elizabeth O. Batonan, duly seconded by Dir. Pedro T. Defensor Jr., be it RESOLVED as it is hereby RESOLVED, to issue a Supplemental Bid Bulletin for the following items under 5.4 as follows:
	 Amendment of National Statistics Office (NSO) to Philippine Statistics Authority (PSA);
	 On 2nd paragraph, rephrase the sentence to: "For this purpose, similar contracts shall refer to any post-harvest facility."
	3. On the 3 rd paragraph, delete <u>"For the procurement of Non-Expendable Supplies and Services:"</u> and retain the sentence as follows:
	"The Bidder must have completed, within the period specified in the Invitation to Bid and ITB Clause 12.1(a)(ii), a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC."

	 After the 3rd paragraph, delete the conjunction <u>"Or"</u> up to the las words of the 8th paragraph <u>"No further instructions"].</u>
GENERAL CONDITIONS OF THE CONTRACT	The BAC members clarified that payment of the Contract Price shall be made by the concerned Extension Offices directly to the winning Bidder/ Supplier.
	On warranty period, it is emphasized that the two (2) year warranty period cannot be compromised because it is a strict instruction/ directive from the Board of Administrator.
	In addition, a penalty of 1/10 of the 1% of the cost of the unperformed portion for every delays will strictly be imposed.
SPECIAL CONDITIONS OF THE CONTRACT	The BAC noted that the rice mills will be delivered to the five (5) Extension Offices (Pagadian, Cagayan de Oro, Davao, Kidapawan and CARAGA) or in the place identified by the CDA Extension Offices.
SCHEDULE OF REQUIREMENTS	Upon motion of Dir. Pedro T. Defensor Jr., duly seconded by Atty Elizabeth O. Batonan, be it RESOLVED as it is hereby RESOLVED, to issue a Supplemental Bid Bulletin in view of the extension of delivery period from forty-five (45) calendar days to sixty (60) calendar days .
TECHNICAL SPECIFICATIONS	Upon instruction of the BAC members, the BAC Secretariat presented the Technical Specifications and other requirements for the Brand New Mobile Mini Rice Mill. After the presentation, the following clarifications were raised by the bidders with regard to the technical specifications:
	 On "Hulling Efficiency (minimum): 80%", Mr. Rodelio Cosico, Jr. o Mariñas Technology Inc. suggested to lower the minimum efficiency rate to 75%.
	Further, this query was supported by Engr. Darwin C. Aranguren of AMTEC-UPLB clarifying therein that the amended minimum efficiency rate issued by the Philippine Agricultural Engineering Standards (PAES) is 75%.
	Upon motion of Atty. Mona Liza A. Arriba-Juarez, duly seconded by Dir. Pedro T. Defensor Jr., be it RESOLVED as it is hereby RESOLVED, to issue a Supplemental Bid Bulletin amending therein the "Hulling Efficiency (minimum): 80%" to " Hulling Efficiency (minimum): 75%".
