**REGULATORY RELIEF FOR
COOPERATIVES IN VIEW OF
PROCLAMATION NO. 922**

REGULATORY RELIEF:

In the light of the above-stated Proclamation No. 922:

- (1) Cooperatives are hereby allowed to postpone their scheduled general assembly meeting and election of officers for a period of three (3) months from the effectivity of this Circular or until such time that State of Public Health Emergency is lifted, whichever comes first.

REGULATORY RELIEF:

In the light of the above-stated Proclamation No. 922:

- (2) Incumbent officers shall be on hold-over capacity until such time that a general assembly meeting and election of officers are conducted.

REGULATORY RELIEF:

In the light of the above-stated Proclamation No. 922:

3. Pending the conduct of general assembly meeting, the cooperative shall operate on a reenacted budget.

REGULATORY RELIEF:

In the light of the above-stated Proclamation No. 922:

Cooperatives which opt to postpone their general assembly meeting and election of officers under this Circular shall be relieved from the following:

1. Conduct of general assembly meeting and election;
2. Conduct of community programs or activities involving a large crowd;
3. Findings of CDA for the following violations:
 - a) Non-presentation to the general assembly of the required reports;
 - b) Non-approval of the development/ annual plan.

REGULATORY RELIEF:

REQUIREMENTS TO AVAIL REGULATORY RELIEF:

- Letter informing CDA Central Office/Extension Office concerned of the postponement of the General Assembly, signed by the Chairperson and/or the CEO/GM of the cooperative;
- Board Resolution requesting availment of the regulatory relief.

REGULATORY RELIEF:

In the light of the above-stated Proclamation No. 922:

In case the postponed general assembly meeting will later on be conducted, the Authority shall be informed of any changes in the submitted reports within five (5) days after the conduct of the said general assembly.

REGULATORY RELIEF:

In the light of the above-stated Proclamation No. 922:

APPLICABILITY PERIOD.

The availment of regulatory relief shall cover **ONLY** the operations of the cooperatives for calendar year **2019**.

**UTILIZATION OF CDF, OPTIONAL FUND,
GRF AND RELEASE OF ISCPR, LOANS
AND OTHER ASSISTANCE TO
COOPERATIVE MEMBERS**

1. **Early distribution of ISCPR will be allowed, subject to adjustments**, when necessary and to explore alternative means to distribute the ISCPR so as to ensure that the distribution process observes the enhanced community quarantine for COVID-19 under the guidance of local authorities and observing strict physical distancing.

2. **Cooperatives are strongly encouraged to utilize their Community Development Fund (CDF), which under Article 86 (3) of R.A. No. 9520, shall not be less than three per centum (3%) of their net surplus,** for projects or activities that will benefit the community where the cooperative operates. These projects or activities are those identified and included in the approved Social Development Plan with the exception, however, of those undertaken in response to the COVID-19 pandemic to reinforce prevention and control actions of the government.

3. The Optional Fund, which under Article 86 (4) of R.A. No. 9520, **shall not exceed seven per centum (7%), may also be utilized by the cooperative, if warranted by the circumstances, for the benefit of its members and employees.**

This, however, must later on be confirmed by the General Assembly.

- 4. If the cooperative chooses not to use its Optional Fund or if the same is not sufficient for the intended aid purpose, **additional fund assistance may be charged to direct expenses.**

- 5. **Accumulated Reserve Fund**, Article 86 (1)(a) of the same Act is clear that same **shall be used for the stability of the cooperative and to meet net losses in its operations.**

Thus, in the event that the cooperative incurs a loss during the year on account of this crisis, only then may the Reserve Fund be used to absorb this loss.

6. **Emergency or calamity loans at interest-free or minimal rates of interest** may be extended to enable the members to meet their needs, subject to the lending policies of the cooperative.

7. **Cooperative-owned vehicles and properties may be made available for use by members of the cooperative or community** especially during emergency situations, in coordination with local government units.

**COMPLIANCE WITH SECTION 4 (AA) OF
REPUBLIC ACT NO. 11469, OTHERWISE
KNOWN AS THE BAYANIHAN TO HEAL
AS ONE ACT**

All cooperatives duly registered by the Authority which provide credit and other lending services are considered “Covered Institutions” under Section 2.01(a), Rule II of the Implementing Rules and Regulations of the above-quoted Section 4(aa) of R.A. No. 11469 and are reminded to **strictly comply with Republic Act No. 11469, otherwise known as the “Bayanihan to Heal As One Act,”** particularly Section 4(aa) which provides:

“SECTION 4. Authorized Powers. – Pursuant to Article VI, Section 23 (2) of the Constitution, the President is hereby authorized to exercise powers that are necessary and proper to carry out the declared national policy.

- The President shall have the power to adopt the following temporary emergency measures to respond to crisis brought by the pandemic.

- (aa) Direct all banks, quasi-banks, financing companies, lending companies, and other financial institutions, public and private, including the Government Service Insurance System, Social Security System and Pag-ibig Fund, to **implement a minimum of a thirty (30)-day grace period for the payment of all loans**, including but not limited to salary, personal, housing, and motor vehicle loans, as well as credit card payments, **falling due within the period of the enhanced Community Quarantine without incurring interests, penalties, fees, or other charges**. Persons with multiple loans shall likewise be given the minimum thirty (30)-day grace period for every loan;"

Corollary thereto, Section 6 of the same Act provides as follows:

“SECTION 6. Penalties. – In addition to acts or omissions already penalized by existing laws, the following offenses shall be punishable with imprisonment of two (2) months or a fine of not less than Ten thousand pesos (P10,000.00) but not more than One million pesos (P1,000,000.00), or both, such imprisonment and fine, at the discretion of the court:

(e) Refusal to provide thirty (30)-day grace periods provided under Section 4;

Provided, however, That if the offender is a corporation, association, partnership or any other juridical person, the penalty shall be imposed upon the president, directors, managers, managing partners, as the case may be, who participated in the commission of the offense or who shall have knowingly permitted or failed to prevent the commission of the same.

- If the offender is an alien, he shall, in addition to the penalties herein prescribed, be deported without further proceedings: Provided, further, That if the offender is a public official or employee, he shall, in addition to the penalties prescribed herein, suffer perpetual or temporary absolute disqualification from office, as the case may be.”

**EXTENSION OF DEADLINE OF
SUBMISSION OF ANNUAL TAX
INCENTIVES REPORT (ATIR) OF
COOPERATIVES TO THE AUTHORITY
DUE TO THE COVID-19 PANDEMIC**

Considering the existence of a national emergency arising from the Coronavirus Disease 2019 (COVID-19) situation and in line with the extension granted by the BIR on the filing of Annual Income Tax Returns until May 15, 2020, the following guidelines are hereby issued:

1. All cooperatives issued with CTE are given up to May 30, 2020 to submit their ATIR for transactions covering the calendar year 2019.
2. Cooperatives which adopt fiscal year as their accounting period are given 15 days from the deadline of the filing of Annual Income Tax Return to the BIR to submit their ATIR.

3. Cooperatives must still follow the procedural guidelines provided for under Section 4 of CDA Memorandum Circular No. 2019-06, in consonance with Rule II, Section 2 of the DOF-CDA-BIR Joint Administrative Order No. 1-2019, requiring all registered cooperatives which were issued a Certificate of Tax Exemption (CTE) and availed of tax incentives to submit to CDA their ATIR.

● **CDA Required Reports**

After online submission using the Cooperative Annual Progress Report Information System (CAPRIS), all duly signed reports may be submitted through any of the following means:

- Personally
- Through registered mail or courier services; or
- Through electronic mail (email)

● Annual Tax Incentives Reports

- The soft copy in excel format shall also be submitted to the email of CDA Regional Offices.
- Hard copies, however, may be submitted in the same manner as the CDA required reports.

In submitting reports through email, the following conditions must be met:

1. Reports must be scanned in a portable document format (PDF)
2. The email should contain a declaration by the authorized representative of the cooperative that the documents submitted are authentic and that the hard copies shall be submitted to the Authority within the prescribed period.
3. It shall be understood however, that the person(s) whose signature(s) appears in the documents submitted shall be held accountable under the appropriate provisions of the Code.

- After evaluation of completed reports and payment of the COC fee of One hundred pesos (P100.00), the Certificate of Compliance (COC) shall be sent via email to the cooperative.
- Payment of COC may be done through Landbank Link.biz portal.
- The original copy of the COC may be claimed at the CDA Office upon lifting of the ECQ.

Application for accreditation of external auditors and training providers.

- a) Applicants may submit their applications and the corresponding documents to the CDA Regional Offices through E-MAIL;
- b) Scanned copies of the documents must be sent to the CDA Regional Office emails

Conduct of mandatory training for cooperative officers.

- a) The accredited cooperative training providers (ATPs) may conduct trainings online or through virtual format;
- b) ATPs may choose to adopt web-based trainings, webinars or other available virtual platforms, or a combination of virtual and homework, whichever is/are most effective in the delivery of trainings for cooperative officers.

- c) ATPs shall still comply with the required contents and minimum number of hours per training by submitting documentary evidence proving compliance thereto.
- d) ATPs shall submit periodic reports through the CDA Regional Offices' email addresses.

As to the other requirements, CEAs and ATPs may refer to the following MCs:

1. Regulatory relief for covered cooperatives who failed to conduct their regular GA meetings because of the community quarantine and which bylaws do not provide for videoconferencing as a mode to conduct their Gas;
2. Regulatory relief for covered coops which have conducted their GA prior to the imposition of the community quarantine but intend to conduct special GA meeting during the said period through videoconferencing, even if not provided in their bylaws;
or
3. General guide and authority for coops who may want to amend their bylaws to include the conduct of their Gas through videoconferencing pending the approval of the said amendment
