RESOLUTION

BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT AND DECLARING THE BIDDER, MYBUSYBEE INC. AS THE SINGLE RATED AND RESPONSIVE BID FOR THE PROJECT, "SUPPLY, DELIVERY, INSTALLATION, AND DEPLOYMENT OF THE ENHANCED COOPERATIVE BUSINESS MATCHING INFORMATION SYSTEM (CBMIS)", under Contract Number CDA-GOODS-2021-02

WHEREAS, the **COOPERATIVE DEVELOPMENT AUTHORITY** through its **BIDS AND AWARDS COMMITTEE (BAC)** advertised/posted the Invitation to Bid through Public Bidding for the Project: **SUPPLY, DELIVERY, INSTALLATION, AND DEPLOYMENT OF THE ENHANCED COOPERATIVE BUSINESS MATCHING INFORMATION SYSTEM (CBMIS)**, under Contract No. CDA-GOODS-2021-02 at the PhilGEPS and CDA Websites and conspicuous place at the CDA Head Office, Bulletin Board-Main Lobby starting June 1, 2021 up to June 22, 2021, with an Approved Budget for the Contract in the amount of P1,360,000.00;

WHEREAS, in accordance with Section 22 of the Revised Implementing Rules and Regulations of Republic Act 9184, a Pre-Bid Conference thru videoconferencing was conducted on June 10, 2021, Thursday, 10:00 A.M., where the BAC discussed the details of the requirements of the Public Bidding as indicated in the Bidding Documents;

WHEREAS, in response to the Invitation to Bid, two (2) Bidders purchased Bidding documents. However, only **MYBUSYBEE INC.** which is located at G7 Burgundy Place, B. Gonzales St., Loyola Heights, Quezon City submitted Bid documents thru electronic submission before the scheduled deadline of submission on June 22, 2021, Tuesday, and the same also attended the Opening of Bids;


