[Not required to be submitted with the Bid, but it shall be submitted within ten (10) days after receiving the Notice of Award]

CONTRACT AGREEMENT

THIS AGREEMENT made the AUG 03 2021 day of _____ 2021 between the **COOPERATIVE DEVELOPMENT AUTHORITY** (hereinafter called "the Entity") of the one part and **MYBUSYBEE INC.** with office address at G7 Burgundy Place, B. Gonzales St., Loyola Heights, Quezon City (hereinafter called "the Supplier") of the other part;

WHEREAS, upon the invitation of the **Entity**, the **Supplier** submitted a bid for the project **SUPPLY, DELIVERY, INSTALLATION, AND DEPLOYMENT OF THE ENHANCED COOPERATIVE BUSINESS MATCHING INFORMATION SYSTEM (CBMIS) WITH CONTRACT NO. CDA-GOODS-2021-02** in the amount of **ONE MILLION ONE HUNDRED NINETY FOUR THOUSAND PESOS (Php1,194,000.00)** inclusive of applicable government taxes and fees (hereinafter called the "Contract Price", which the Entity subsequently accepted pursuant to Bids and Awards Committee Resolution No. 2021-040.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding (Electronic), as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;



- iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **ONE MILLION ONE HUNDRED NINETY FOUR THOUSAND PESOS (PhP1,194,000.00)** or such other sums as may be ascertained, **MYBUSYBEE INC.** agrees to the **SUPPLY, DELIVERY, INSTALLATION, AND DEPLOYMENT OF THE ENHANCED COOPERATIVE BUSINESS MATCHING INFORMATION SYSTEM (CBMIS)** in accordance with his/her/its Bid.
 4. The **COOPERATIVE DEVELOPMENT AUTHORITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




