No Certified True Copy stamped on the documents provided	The failure of Tiaxa Philippines, Inc. to indicate that the documents submitted are certified true copies and that not all pages were signed by the authorized signatory are not sufficient grounds to disqualify or declare the Bidder as Ineligible.  Per NPM No. 009-2014, the GPPB explained that submitted documents need not be originals or certified true copies, as the rules recognize the submission of copies as satisfactory compliance with the requirements. The Omnibus Sworn Statement of the bidder sufficiently certifies that each of the documents submitted in satisfaction of the bidding requirements is an authentic copy of the original, complete, and all statements and information provided therein are true and correct.

5. Single Largest Completed Contract – Contract Date and Date of Acceptance is the same	We believe that this issue was sufficiently addressed during the opening of bids.

**WHEREAS**, on September 23, 2021, REDCAT Workers Service Cooperative filed a motion for reconsideration on the decision of the BAC disqualifying its bid to the herein project;

**WHEREAS**, the BAC discussed and deliberated upon the motion for reconsideration filed by REDCAT Workers Cooperative where the crux of the issue was its failure to state Comply to items under rows 7 to 12.5 of the Technical Specifications;

**WHEREAS**, the BAC, after careful examination of the justification cited by REDCAT Workers Service Cooperative in its motion for reconsideration, underscored that those items under rows 7 to 12.5 of Section VII of the bidding documents form an integral part of the technical specifications required of the herein project. Thus, each specification has a corresponding performance parameter for which a response of Comply or Not Comply is required to be stated and thus resolved to deny the motion for reconsideration filed by REDCAT Workers Service Cooperative;

**WHEREAS**, on September 23, 2021, the BAC resolved and declared **REDCAT WORKERS SERVICE COOPERATIVE disqualified for the Project, REBID - DEVELOPMENT, SUPPLY, DELIVERY, INSTALLATION, CONFIGURATIONS AND DEPLOYMENT OF ELECTRONIC DOCUMENT TRACKING AND MANAGEMENT INFORMATION SYSTEM (EDTMIS)** under Contract No. CDA-GOODS-2021-04 and instructed the Technical Working Group to conduct the post qualification process on MICROGENESIS Business Systems- the bidder who ranked number 2 in the results of Bid Evaluation, subject to the existing rules and regulations of Republic Act No. 9184 and its Implementing Rules and Regulations.

**WHEREAS**, upon careful examination, validation and verification of all the eligibility/technical and financial requirements conducted by the TWG on September 27, 2021, **MICROGENESIS SOFTWARE INC., doing business under the name and style of MICROGENESIS BUSINESS SYSTEMS**, being the Second Lowest Calculated Bid, was found to be responsive and thus post-qualified;
