**CONTRACT AGREEMENT**

WHEREAS, upon the invitation of the **Entity**, the **Supplier** submitted a bid for the project **PROCUREMENT OF SECURITY MANPOWER SERVICES AT CDA HEAD OFFICE FOR CY 2022 WITH CONTRACT NO. CDA-GOODS-2021-06** in the amount of **TWO MILLION EIGHT HUNDRED EIGHTY THOUSAND THREE HUNDRED TWENTY ONE PESOS AND 24/100 (Php2,880,321.24)** inclusive of applicable government taxes and fees (hereinafter called the "Contract Price", which the Entity subsequently accepted pursuant to Bids and Awards Committee Resolution No. 2021-070.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding (Electronic), as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **TWO MILLION EIGHT HUNDRED EIGHTY THOUSAND THREE HUNDRED TWENTY ONE PESOS AND 24/100 (PhP2,880,321.24)** or such other sums as may be ascertained, **MARBAN SECURITY & INVESTIGATION AGENCY, INC.** agrees to the **PROCUREMENT OF SECURITY MANPOWER SERVICES AT CDA HEAD OFFICE FOR CY 2022** in accordance with his/her/its Bid.
  4. The **COOPERATIVE DEVELOPMENT AUTHORITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
