RESOLUTION

BAC RESOLUTION DECLARING A FAILURE OF BIDDING FOR THE PROJECT PROCUREMENT OF 1-YEAR WIFI CONNECTIVITY SUBSCRIPTION FOR THE DIGITALIZATION OF COOPERATIVE DEVELOPMENT AUTHORITY WITH CONTRACT NO. CDA-2021-08

WHEREAS, the COOPERATIVE DEVELOPMENT AUTHORITY through its BIDS AND AWARDS COMMITTEE (BAC) advertised/posted the Invitation to Bid through Public Bidding for the Project: **PROCUREMENT OF 1-YEAR WIFI** SUBSCRIPTION CONNECTIVITY FOR THE DIGITALIZATION OF COOPERATIVE DEVELOPMENT **AUTHORITY** WITH CONTRACT NO. CDA-2021-08 at the PhilGEPS and CDA Websites and conspicuous place at the CDA Head Office, Bulletin Board-Main Lobby starting December 30, 2021 up to January 25, 2022 with an Approved Budget for the Contract in the amount of P10,000,000.00;

WHEREAS, in accordance with Section 22 of the Revised Implementing Rules and Regulations of Republic Act 9184, a Pre-Bid Conference thru videoconferencing was conducted on January 10, 2022, Monday, 2:00 P.M., the BAC discussed the details of the requirements of the Public Bidding as indicated in the Bidding Documents;

WHEREAS, the opening of bids thru videoconferencing was conducted on January 25, 2022, Tuesday, 10:00 A.M. by the CDA-BAC;

WHEREAS, during the proceedings for the opening of bids, the BAC Secretariat reported and confirmed that no bids were received on the deadline for submission and receipt of bids;

WHEREAS, Section 35.1 of the Revised IRR of RA 9184 states that the BAC shall declare the bidding a failure when, a) No bids are received; b) All prospective bidders are declared ineligible; c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or d) The bidder with the LCRB, HRRB, SCRB or SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and its IRR;

NOW, THEREFORE, for and in consideration of the foregoing, the Members of the CDA Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED** the following:

- (1) To declare **FAILURE OF BIDDING**;
- (2) To recommend for mandatory review and evaluation of the terms and conditions, and specifications in the Bidding Documents, including cost estimates;
- (3) To request the End-user and the MIS to submit the revised terms, conditions, and specifications subject to the required approvals; and
- (4) To conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the revised IRR of RA 9184.
