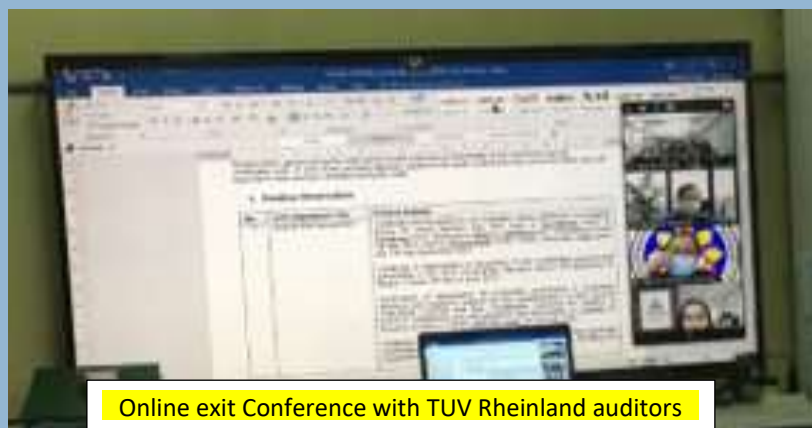


EVENTS in NOVEMBER
