CONTRACT AGREEMENT

THIS AGREEMENT made the 14 JUL 2022 day of _____ 2022 between the **COOPERATIVE DEVELOPMENT AUTHORITY** (hereinafter called "the Entity") of the one part and **TOYOTA QUEZON AVENUE, INC.** with business address located at 728 Quezon Avenue, Quezon City (hereinafter called "the Supplier") of the other part;

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding (Electronic), as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

CDA-2022-02** in accordance with his/her/its Bid.
 4. The **COOPERATIVE DEVELOPMENT AUTHORITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


