ORGANIZATION OF THE LOCAL MONITORING COMMITTEE FOR

TRANSPORT COOPERATIVES

Pursuant to the provision of RA 9520, Rule V Transportation Service Cooperatives particularly on Section 8 Monitoring Committee - All CDA Regional Extension Offices are hereby ordered to organize/create their Local Monitoring Committee for Transport Cooperatives.

Section 1. Legal Basis

Section 8. Monitoring Committee.

A monitoring committee has been created, composed of a representative from the Authority, who shall be the Ex-Officio Chairperson thereof, and representatives of the LTO, LTFRB, OTC, LGU, other concerned government agencies as may be necessary, and the National Federation of Transport Cooperatives as members.

Likewise, a Local Monitoring Committee has been created in all CDA extension to facilitate the monitoring of these Transportation Service Cooperatives.

The permanent Secretariat shall come from the Authority.

Section 2. General Guidelines

The Monitoring Committee shall be composed of the following:

- CDA Regional Director as Chairperson
- OTC Representative
- LTFRB Regional Director or his duly Authorized Representative
- LTO Representative
- MARINA Representative
- DILG Regional Director or his duly authorized representative representing the LGUs of the region

- To oversee and monitor the ongoing PUVM Program
- To monitor the implementation of the Service Contracting Program
- · To assist in settling intra and inter cooperative dispute
- To recommend changes from time to time as it may deem necessary

Section 3. Information and Dissemination

All CDA Regional Offices are ordered to create/organize their Local Monitoring Committee for Transport Cooperatives.

Section 4. Effectivity

This Memorandum Circular shall take effect fifteen (15) days after its publication in the Official Gazette.
