BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT AND DECLARING THE BIDDER - INNOVE COMMUNICATIONS, INC. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT "RENEWAL AND UPGRADE OF LICENSES FOR THE SUBSCRIPTION OF ONE (1) YEAR ZOOM VIDEO CONFERENCING SERVICES FOR THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA) FOR THE YEAR 2022-2023 (August 02, 2022 to August 02, 2023) WITH CONTRACT NO.
