CDA-2022-03** in the amount of **ONE MILLION THREE HUNDRED FORTY THREE THOUSAND NINE HUNDRED THIRTY PESOS AND 78/100 (P1,343,930.78)** inclusive of applicable government taxes and fees (hereinafter called the "Contract Price", which the Entity subsequently accepted pursuant to Bids and Awards Committee Resolution No. 2022-109.

bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **ONE MILLION THREE HUNDRED FORTY THREE THOUSAND NINE HUNDRED THIRTY PESOS AND 78/100 (P1,343,930.78)** or such other sums as may be ascertained, **INNOVE COMMUNIATIONS, INC.** agrees to the **RENEWAL AND UPGRADE OF LICENSES FOR THE SUBSCRIPTION OF ONE (1) YEAR ZOOM VIDEO CONFERENCING SERVICES FOR THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA) FOR THE YEAR 2022-2023 (August 2, 2022 to August 2, 2023) WITH CONTRACT NO. CDA-2022-03** in accordance with his/her/its Bid.
4. The **COOPERATIVE DEVELOPMENT AUTHORITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


