- a) The amount of not less than **Three Hundred Twelve Thousand (Php 312,000)** [equivalent to two percent (2%) of ABC], if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit
- b) The amount of not less than **Seven Hundred Eighty Thousand Pesos (Php 780,000.00)** [equivalent to five percent (5%) of ABC] if bid security is in Surety Bond


Refusal to accept the award without justifiable reason and failure to provide the performance security within the prescribed period of ten (10) days shall constitute sufficient ground for cancellation of the award, forfeiture of the bid security and disqualification in any future bidding of this authority.

Please acknowledge agreement of this NOA by formally signing on the space provided below and return the same to the Office of the Regional Director within the specified period stated above.




