



INVITATION TO BID for the

PROCUREMENT OF A ONE (1) YEAR SUBSCRIPTION OF CLOUD BASED ELECTRONIC MAIL SERVICES FOR THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA) FOR THE YEAR 2023-2024 WITH CONTRACT NUMBER CDA-2023-01

- The COOPERATIVE DEVELOPMENT AUTHORITY (CDA) Head Office, through the FY 2023 General Appropriations Act, intends to apply the sum of SIX MILLION SIX HUNDRED SIX THOUSAND SEVEN HUNDRED SEVEN PESOS AND 80/100 (P6,606,707.80) being the Approved Budget for the Contract (ABC) to payments under contract for the PROCUREMENT OF A ONE (1) YEAR SUBSCRIPTION OF CLOUD BASED ELECTRONIC MAIL SERVICES FOR THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA). Bids received in excess of the ABC shall be automatically rejected at Bid opening.
- 2. The CDA through its Bids and Awards Committee (BAC) now invites eligible and interested Bidders for the above Procurement Project. Duration of the project is ONE (1) YEAR upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project, within the last five (5) years from the date of submission and receipt of bids. The description of the eligible bidder is contained in Section II of the Bidding Documents, Instruction to Bidders (ITB).
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183.

- 4. Prospective Bidders may obtain further information from CDA Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below during office hours and as posted on the website of the CDA and the Philippine Government Electronic Procurement System (PhilGEPS).
- 5. A complete set of Bidding Documents may be purchased by interested Bidders starting February 22, 2023 from the address given below and upon payment of a non-refundable fee for the Bidding Documents in the amount of SEVEN THOUSAND PESOS (P7,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees through electronic means.

It may also be **downloaded free of charge** from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the CDA, provided that bidders shall pay the fee for the Bidding Documents not later than the submission and opening of bids.

- 6. The CDA BAC will hold a PRE-BID CONFERENCE on March 02, 2023, Thursday, 10:00 A.M. through videoconferencing which shall be open to all prospective bidders. Interested bidders must accomplish a form to be given a link to join the Pre-bid conference virtually. To access the form, please find the link and/or scan the QR code provided in the next page.
- 7. Bids must be duly received by the BAC Secretariat through online or electronic submission via <u>bacsecretariat@cda.qov.ph</u> on or before March 15, 2023 or at the latest one (1) hour before the deadline of the opening of bids (or at 9:00 A.M. of March 15, 2023), provided that the email is encrypted, the file is in a zip format and password-protected in strict compliance with GPPB Resolution no. 09-2020 dated 07 May 2020. The password to access the file shall only be disclosed by the bidders during the actual bid opening. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. **BID OPENING shall be on March 15, 2023, Wednesday, at 10:00 A.M.** via videoconferencing. The bids shall be opened in the presence of the bidders or their duly authorized representatives who choose to attend the virtual meeting. Interested bidders must accomplish a form to be given a link to join the Opening of Bids virtually. To access the form, please find the link and/or scan the QR code provided in the next page.
- 10. The CDA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
