BIDS AND AWARDS COMMITTEE RESOLUTION NO. 019 Series of 2023

RECOMMENDING AWARD CONTRACT FOR THE PROCUREMENT OF LEASE OF VENUE WITH MEALS AND ACCOMMODATION THROUGH NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT

WHEREAS, on July 17, 2023, the Officer in Charge Juriski B. Mangelen, as the Head of Procuring Entity (HoPE), approved the purchase request for the Procurement of the Lease of Venue with Meals and Accommodation at Glan, Sarangani Province.

WHEREAS, with an Approved Budget for the contract (ABC) of Two Hundred Fifty Thousand Pesos (P250,000.00), the Procurement of the Lease of Venue with Meals and Accommodation will be acquired pursuant to Section 53.9 Small Value Procurement of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184.

WHEREAS, the BAC, through its Secretariat, posted the Request for Quotation on July 19, 2023 at Philippine Government Electronic Procurement System (PhilGEPS) and set deadline of submission of bids on July 25, 2023 and initiated the procurement activity by sending Request for Quotations ((RFQ) to three (3) prospective suppliers, viz: 1. **Isla Jardin del Mar**, 2. **Bai Resort** and 3. **Anvy Resort Hotel**.

WHEREAS, before the lapse of the deadline for submission of quotation, Bai Resort and Anvy Resort Hotel submitted its Quotation.

WHEREAS, upon careful review of the Bids and Award Committee on the legal requirements submitted by **BAI RESORT AND ANVY RESORT HOTEL** it was found that BAI RESORT AND ANVY RESORT HOTEL are compliant with the eligibility requirements as evidenced by submission of its Mayor's/Business Permit, BIR Registration and provision of PhilGEPS Registration Number.

WHEREAS, the proposal of **ANVY RESORT HOTEL** in the amount of **One Hundred Seventy-Six Thousand Four Hundred Forty Pesos (P176,440.00)** found to be the lowest calculated and responsive quotation.

WHEREAS, the BAC proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant, and, thus, being recommended to be declared as the lowest calculated and responsive quotation for consideration of award of contract;

NOW, THEREFORE, premises considered, the **BIDS AND AWARDS COMMITTEE**, hereby resolve to recommend to the HoPE, for her consideration and approval, the award of contract for the Procurement of the Lease of Venue with Meals and Accommodation to **ANVY**



RESORT HOTEL in the amount of **One Hundred Seventy-Six Thousand Four Hundred Forty Pesos (P176,440.00)**.




