**WHEREAS**, in accordance with Section 22 of the Revised Implementing Rules and Regulations of Republic Act 9184, a Pre-Bid Conference thru videoconferencing was conducted on **February 16, 2024, Friday, 1:00 PM**, the BAC discussed the details of the requirements of the Public Bidding as indicated in the Bidding Documents;
