RESOLUTION

BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT AND DECLARING GREAT AGRICULTURAL PRODUCTS AND BUILDERS DEVELOPMENT CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT "PROCUREMENT OF 1 LOT SUPPLY AND DELIVERY OF DIGITAL 2-IN-1 CORN MILL COMBINED RICE MILL WITH 10 KVA GENERATOR SET" under Contract Number CDA-GOODS-2024-03
