RESOLUTION

BAC RESOLUTION DECLARING A FAILURE OF BIDDING FOR THE PROJECT "SUPPLY AND DELIVERY OF 291 UNITS OF LAPTOP COMPUTERS FOR THE COOPERATIVE DEVELOPMENT AUTHORITY FOR FY 2024" UNDER CONTRACT NUMBER CDA-GOODS-2024-04

WHEREAS, the **COOPERATIVE DEVELOPMENT AUTHORITY** through its **BIDS AND AWARDS COMMITTEE (BAC)** advertised/posted the Invitation to Bid through Public Bidding for the Project: **SUPPLY AND DELIVERY OF 291 UNITS OF LAPTOP COMPUTERS FOR THE COOPERATIVE DEVELOPMENT AUTHORITY FOR FY 2024** under Contract No. **CDA-GOODS-2024-04** at the PhilGEPS and CDA Websites and conspicuous place at the CDA Head Office Bulletin Board-Main Lobby starting **May 10, 2024** up to **June 19, 2024** with an Approved Budget for the Contract in the amount of **NINETEEN MILLION TWO HUNDRED FIFTY THOUSAND PESOS (P19,250,000.00)**;

WHEREAS, in accordance with Section 22 of the Revised Implementing Rules and Regulations of Republic Act 9184, a Pre-Bid Conference thru videoconferencing was conducted on **May 28, 2024, Tuesday, 10:00 AM**, the BAC discussed the details of the requirements of the Public Bidding as indicated in the Bidding Documents;

WHEREAS, in response to the Invitation to Bid, only 1 Bidder, **SONKKENS OFFICE EQUIPMENT TRADING** business address located at 140 J.P. LAUREL HIGHWAY, MATAAS NA LUPA, LIPA CITY purchased the Bidding Documents and submitted its bid proposal thru electronic submission before the scheduled deadline on **June 19, 2024, 9:00 AM**, and attended the Opening of Bids;

WHEREAS, in accordance with Rule IX Bid Evaluation, Section 30 of RA 9184, the BAC conducted the opening of bids and preliminary examination thru videoconferencing with the following results:

WHEREAS, after having determined the bidder – **SONKKENS OFFICE EQUIPMENT TRADING**, to be qualified based on the Abstract of Bids as Read, the BAC accepted its bid proposal subject to bid evaluation;

WHEREAS, on **June 19, 2024**, the BAC resolved and declared **SONKKENS OFFICE EQUIPMENT TRADING** as the bidder with the Single Calculated Bid for the Project: **SUPPLY AND DELIVERY OF 291 UNITS OF LAPTOP COMPUTERS FOR THE COOPERATIVE DEVELOPMENT AUTHORITY FOR FY 2024** under Contract No. **CDA-GOODS-2024-04** and instructed the Technical Working Group to conduct the post qualification process, subject to the existing rules and regulations of Republic Act No. 9184 and its Implementing Rules and Regulations;

WHEREAS, upon careful examination, validation and verification of all the eligibility/technical and financial requirements conducted by the Technical Working Group on June 25, 2024, the following results were presented:

After arithmetical validation/corrections, the bid of Sonkkens Office Equipment Trading in the amount of ₱19,206,000.00, or 99.77% of the ABC was found to be correct in words and figures.

Following Sec.34 Rule X of the Revised IRR of R.A. No. 9184, Sonkkens Office Equipment Trading was subjected to detailed bid evaluation, including the checking of actual laptop computers offered which was completed on July 02, 2024, and post-qualification. The bidder met all the requirements in the Terms of Reference (TOR) except on the following:

1) Incompatible Antivirus Software Offered. Sonkkens Office Equipment Trading offered ESET Antivirus in the initial bid submitted which is incompatible with our existing Sophos Firewall. This mismatch could lead to operational challenges and support issues due to the lack of integration between products from different vendors, thereby, potentially violating the Contractor's warranty obligations to strictly adhere to the TOR. The bidder proposed replacing the ESET Antivirus with Sophos Endpoint subject to the approval of the Bids and Award Committee (BAC).

2) Non-submission of Certificate of Genuineness and/or Authenticity. Sonkkens Office Equipment Trading failed to provide the Certificate of Genuineness and/or Authenticity for the 291 pieces of Microsoft Office 2021 (Perpetual License).

Technical component of Bid – NOT COMPLIED/FAILED
Financial component of Bid – COMPLIED/PASSED

WHEREAS, the BAC deliberated the TWG Post Qualification results and upon motion duly seconded, as there was no objection to the findings, the Bids and Awards Committee recommended the Bid of **SONKKENS OFFICE EQUIPMENT TRADING** for the project **SUPPLY AND DELIVERY OF 291 UNITS OF LAPTOP COMPUTERS FOR THE COOPERATIVE DEVELOPMENT AUTHORITY FOR FY 2024** under Contract No. **CDA-GOODS-2024-04** as **Non-Compliant / Non-Responsive** for its failure to comply with the technical component of the Bidding Documents.

WHEREAS, Section 35.1 of the Revised IRR states that the BAC shall declare the bidding a failure when, a) No bids are received; b) All prospective bidders are declared ineligible; c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or d) The bidder with the LCRB, HRRB, SCRB or SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and its IRR;

NOW, THEREFORE, for and in consideration of the foregoing, the Members of the CDA Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED** the following:

- (1) To declare **FAILURE OF BIDDING**;
- (2) To notify **SONKKENS OFFICE EQUIPMENT TRADING** of its failure to pass the Post-qualification conducted by the TWG
- (3) To recommend for mandatory review and evaluation of the terms and conditions, and specifications in the Bidding Documents, including cost estimates;
- (4) To request the End-user – ICTD to submit the revised terms, conditions and specifications subject to the required approvals with abstract market research; and
- (5) To conduct a re-bidding with re advertisement and/or posting, as provided for in Section 21.2 of the revised IRR of R.A. 9184.
