### RESOLUTION

**RESOLUTION DECLARING A SECOND FAILURE OF BIDDING AND RECOMMENDING TO RESORT TO NEGOTIATED PROCUREMENT – TWO-FAILED BIDDINGS FOR THE SUPPLY AND DELIVERY OF 291 UNITS OF LAPTOP COMPUTERS FOR THE COOPERATIVE DEVELOPMENT AUTHORITY FOR FY 2024 (REBID)**

**WHEREAS**, the Bids and Awards Committee (BAC) issued Resolution No. 2024-093A declaring the first failure of bidding and recommending for the rebid of the **Supply and Delivery of 291 Units of Laptop Computers for the Cooperative Development Authority for FY 2024**;

**WHEREAS**, the BAC conducted a pre-procurement conference to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates on September 10, 2024;

**WHEREAS**, the Cooperative Development Authority (CDA) posted the Invitation to Bid for the **Supply and Delivery of 291 Units of Laptop Computers for the Cooperative Development Authority for FY 2024 (Rebid)**, through competitive bidding with Purchase Request No. 2024-175 having an Approved Budget for the Contract (ABC) of **Nineteen Million Two Hundred Fifty Thousand Pesos (₱ 19,250,000.00)** in "PhilGEPS" and CDA websites on September 13, 2024 and in conspicuous places at the premises of the CDA continuously for twenty-four (24) days;

**WHEREAS**, the BAC also invited the representative/s from the Department of Information and Communications Technology (DICT), Philippine Chamber of Commerce & Industry (PCCI), Procurement Service – Department of Budget and Management (PS-DBM), and Commission on Audit (COA) to act as observers for the whole bidding procedures;

**WHEREAS**, a hybrid Pre-Bid Conference was conducted on **September 23, 2024, 10:00 a.m.** and was attended by twelve (12) prospective bidders, namely, Advance Solutions Inc., Net Global Solutions Inc., Columbia Technologies Inc., Maxcor Inter-ventures Co., Goldne Enterprises, Pronet System Intergrated Network Solutions, Advance Connect Technologies Inc., Techsolve System Solutions Inc., Accent Micro Technologies Inc., Joneco Tech Marketing Corp., ENJ Corp Asia Inc., and Sonkkens Office Equipment;

**WHEREAS**, Bid Bulletin No. 1 was issued on **September 24, 2024** to inform all prospective bidders on the clarifications/ changes made in the Bidding Documents as a result of the discussion during the pre-bid conference;

**WHEREAS**, two (2) bidders, namely, **Sonkkens Office Equipment Trading and Advance Connect Technologies Inc.**, bought the Bidding Documents and submitted their bids on or before the bid opening scheduled on **October 7, 2024, 9:00 a.m.**;



**WHEREAS**, the bids submitted were found to be substantially complying with respect to its technical and financial components, to wit:

**WHEREAS**, the detailed bid evaluation conducted on **October 8, 2024** resulted to the following:

**WHEREAS**, as part of the post-qualification activity, the Technical Working Group (TWG) and end-user representatives from the Information and Communications Technology Division (ICTD) conducted a site inspection on **October 10, 2024** to further confirm the compliance of **Sonkkens Office Equipment Trading**, the bidder with the lowest calculated bid, to the requirements of this bidding;

**WHEREAS**, the TWG reported to the BAC on **October 16, 2024** that **Sonkkens Office Equipment Trading** failed to meet the required Single Largest Completed Contract (SLCC) similar to the procurement project as stipulated in the Bidding Documents;

**WHEREAS**, the BAC accepted the report made by the TWG and requested to complete the conduct of post-qualification process to the remaining bidder;

**WHEREAS**, on **October 17, 2024**, the TWG and the end-user representatives continued the post-qualification process;

**WHEREAS**, the TWG reported to the BAC on **October 28, 2024** that **Advance Connect Technologies Inc.** failed to comply the one (1) year international warranty and one (1) year on laptop batteries as indicated in the technical specifications of the Bidding Documents;

**WHEREAS**, the BAC accepted the report made by the TWG and found that all bids failed the post-qualification;

**WHEREAS**, considering the results of post-qualification, the BAC shall declare a failure of bidding in accordance to Section 35.1 of the 2016 IRR of R.A. No. 9184.

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare a second failure of bidding for the **Supply and Delivery of 291 Units of Laptop Computers for the Cooperative Development Authority for FY 2024 (Rebid)**; and
2. To recommend to the Head of the Procuring Entity of the Cooperative Development Authority to resort to the conduct of negotiated procurement – two-failed biddings for the **Supply and Delivery of 291 Units of Laptop Computers for the Cooperative Development Authority for FY 2024 (Rebid)**.


