RESOLUTION DECLARING THE BID OF PINNACLE TECHNOLOGIES INC. AS THE SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING THE AWARD OF THE CONTRACT TO THE SAID COMPANY FOR THE “ENHANCEMENT OF THE CDA’S COOPERATIVE SYSTEMS (CS) PROJECT FOR FY 2024 (RE-BID)” WITH PROJECT ID NO. CDA-GOODS-2024-11

WHEREAS, the Bids and Awards Committee (BAC) conducted a pre-procurement conference for the “ENHANCEMENT OF THE CDA’S COOPERATIVE SYSTEMS (CS) PROJECT FOR FY 2024 (RE-BID)” with Project ID No. CDA-GOODS-2024-11 with Purchase Request No. 2024-225 having an Approved Budget for the Contract (ABC) of **TWELVE MILLION PESOS ONLY (P12,000,000.00) on November 28, 2024;**

WHEREAS, the Cooperative Development Authority (CDA) posted its Invitation to Bid for the aforesaid procurement project in “Phil-GEPS” and CDA websites on **November 29, 2024** and at the CDA Head Office Bulletin Board in the Main Lobby continuously for 21 days;

WHEREAS, the BAC also invited the representative/s from the Commission on Audit (COA), Procurement Service – Department of Budget and Management (PS-DBM), Philippine Chamber of Commerce & Industry (PCCI), and National Confederation of Cooperatives (NATCCO) to act as observers for the whole bidding procedures;

WHEREAS, the Pre-Bid Conference was conducted on **December 6, 2024** and was attended by five (5) prospective bidders, namely, 1) PINNACLE TECHNOLOGIES INC., and 2) 10-17 CONSULIT TECHNOLOGIES & SERVICES INC., 3) MYBUSYBEE INC. 4) DOZ OUTSOURCING SERVICES OPC, and 5) UNEXUS MEDICAL SOLUTIONS, INC.;

WHEREAS, one (1) bidder, namely, **PINNACLE TECHNOLOGIES INC.**, bought the bidding documents and submitted their bid on or before the bid opening scheduled on **December 19, 2024;**

WHEREAS, the bid submitted by the following bidders were found to be substantially complying with respect to its technical and financial components, to wit:


