RESOLUTION

RESOLUTION DECLARING A FAILURE OF BIDDING – FOR THE ENHANCEMENT OF THE CDA'S COOPERATIVE SYSTEMS (CS) PROJECT FOR FY 2024

WHEREAS, the Bids and Awards Committee (BAC) conducted a pre-procurement conference for the **ENHANCEMENT OF THE CDA'S COOPERATIVE SYSTEMS (CS) PROJECT FOR FY 2024** with Project ID No. CDA-GOODS-2024-09 with Purchase Request No. **2024-225** having an Approved Budget for the Contract (ABC) of **TWELVE MILLION PESOS ONLY (P12,000,000.00)** on **November 4, 2024**;

WHEREAS, the Cooperative Development Authority (CDA) posted its Invitation to Bid for the aforesaid procurement project in "Phil-GEPS" and CDA websites on **November 7, 2024** and at the CDA Head Office Bulletin Board in the Main Lobby continuously for twenty-one (21) days;

WHEREAS, the BAC also invited the representative/s from the National Confederation of Cooperatives (NATCCO), Philippine Chamber of Commerce & Industry (PCCI), Procurement Service – Department of Budget and Management (PS-DBM), and Commission on Audit (COA) to act as observers for the whole bidding procedures;

WHEREAS, an online Pre-Bid Conference was conducted on **November 15, 2024, 1:30 PM** and was attended by two (2) prospective bidders, namely, **DOZ OUTSOURCING SERVICES OPC**, and **BEACON SOLUTIONS, INC.**;

WHEREAS, Bid Bulletin No. 1 was issued on **November 19, 2024** to inform all prospective bidders on the clarifications/ changes made in the Bidding Documents as a result of the discussion during the pre-bid conference;

WHEREAS, no bids were received during the submission and opening of bids on **November 27, 2024**;

WHEREAS, Section 35.1 (a), Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184 provides that the BAC shall declare the bidding a failure when no bids are received;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare a failure of bidding for the **ENHANCEMENT OF THE CDA'S COOPERATIVE SYSTEMS (CS) PROJECT FOR FY 2024**; and



2. To recommend to the Head of the Procuring Entity of the Cooperative Development Authority the re-bid of the **ENHANCEMENT OF THE CDA'S COOPERATIVE SYSTEMS (CS) PROJECT FOR FY 2024.**
