RESOLUTION

RESOLUTION DECLARING THE QUOTATION OF SONKKENS OFFICE EQUIPMENT TRADING AS THE LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING THE AWARD OF THE CONTRACT TO THE SAID COMPANY FOR THE SUPPLY AND DELIVERY OF 291 UNITS OF LAPTOP COMPUTERS FOR THE COOPERATIVE DEVELOPMENT AUTHORITY (NEGOTIATED PROCUREMENT AFTER TWO-FAILED BIDDINGS)

WHEREAS, the Cooperative Development Authority (CDA) through its Bids and Awards Committee (BAC) issued Resolution No. 2024-114 and declaring the first failure of bidding and recommending for the rebid of the **Supply and Delivery of 291 Units of Laptop Computers for the Cooperative Development Authority for FY 2024**;

WHEREAS, the same issued BAC Resolution No. 2024-155B declaring the second failure of bidding and recommending to resort to Negotiated Procurement (Two-Failed Biddings);

WHEREAS, the BAC conducted a pre-procurement conference on **October 30, 2024**, reviewed the terms, conditions, and specifications and revised the technical, legal and financial eligibility requirement and Terms of Reference;

WHEREAS, the CDA-BAC posted the Invitation for Negotiated Procurement for the **Supply and Delivery of 291 Units of Laptop Computers for The Cooperative Development Authority for FY 2024** at the Phil-GEPS and CDA websites on **November 7, 2024** and at the CDA Head Office Bulletin Board in the Main Lobby continuously for **nine (9) days**;

WHEREAS, the BAC also invited the representative/s from the Commission on Audit (COA), Philippine Chamber of Commerce & Industry (PCCI), and National Confederation of Cooperatives (NATCCO) to act as observers for the whole procurement procedures;

WHEREAS, the Negotiation Meeting was conducted on **November 11, 2024** and was attended by **seven (7)** prospective bidders, namely, SONKKENS OFFICE EQUIPMENT TRADING, MAXIMUM SOLUTIONS CORPORATION, INFINITE MINDS INFORMATION TECHNOLOGY SOLUTION, COLUMBIA TECHNOLOGIES, INC., MASANGKAY COMPUTER CENTER, ADVANCE CONNECT TECHNOLOGIES INC., TECHSOLVE SYSTEM SOLUTIONS INC., AND ADVANCE SOLUTIONS, INC;



WHEREAS, two (2) suppliers, namely, SONKKENS OFFICE EQUIPMENT TRADING, and ADVANCE CONNECT TECHNOLOGIES INC. submitted their quotations on or before the opening scheduled on November 15, 2024;

WHEREAS, the quotations submitted by the following suppliers were found to be substantially complying with respect to the Terms of Reference & eligibility requirements, to wit:

- b) To recommend to the Head of the Procuring Entity of the Cooperative Development Authority that the contract for the **Supply and Delivery of 291 Units of Laptop Computers for the Cooperative Development Authority** be awarded to **SONKKENS OFFICE EQUIPMENT TRADING**.


