Subject : QUALIFICATION OF CONVICTED PERSONS WHO ARE UNDER

PROBATION TO FORM OR JOIN COOPERATIVES -

During the last MANCOM, Dir. Pinter inquired whether convicted persons who are under probation are qualified to join/form cooperatives.

Quoted are the pertinent provisions of P.D. 968.

*Section 3. Reaning of Terms.

- a) Probation is a disposition under which a defendant, after conviction and sentence, is released subject to conditions imposed by the court and to the supervision of a probation officer.
- b) Probationer means a person placed on probation.

"Section 16. Termination of Probation. After the period of probation and upon consideration of the report and recommendation of the probation officer, the court may order the final discharge of the probationer upon finding that he has fulfilled the terms and conditions of his probation and thereupon the case is deemed terminated.

The final discharge of the probationer shall operate to restore to him all civil rights lost or suspended as a result of his conviction and to fully discharge his liability for any fine imposed as to offense for which probation was granted.

The probationer and the probation officer shall each be furnished with a copy of such order.

From the above quoted provisions of the law on probation, persons convicted of certain crimes who are under probation are disqualified to form or join cooperatives during the period of probation. Only after termination of the period of probation (final discharge) a convicted person placed iunder probation is qualified to form/join cooperatives.
