RESOLUTION DECLARING THE BID OF MAROONSTUDIOS, INC. AS THE SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING THE AWARD OF THE CONTRACT TO THE SAID COMPANY FOR THE "PROCUREMENT OF ONE (1) YEAR SUBSCRIPTION OF CLOUD BASED ELECTRONIC MAIL SYSTEM FOR THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA) FOR THE YEAR 2025-2026" WITH PROJECT ID NO. CDA-GOODS-2025-01

WHEREAS, the Bids and Awards Committee (BAC) conducted a pre-procurement conference for the "PROCUREMENT OF ONE (1) YEAR SUBSCRIPTION OF CLOUD BASED ELECTRONIC MAIL SYSTEM FOR THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA) FOR THE YEAR 2025-2026" with Project ID No. CDA-GOODS-2025-01 with Purchase Request No. 2025-009 having an Approved Budget for the Contract (ABC) of **TWELVE MILLION SIX HUNDRED FIFTY-FIVE THOUSAND THREE HUNDRED SEVENTY PESOS & 4/100 (Php12,655,370.04)** on **January 21, 2025**;

WHEREAS, the Cooperative Development Authority (CDA) posted its Invitation to Bid for the aforesaid procurement project in "Phil-GEPS" and CDA websites on **January 23, 2025** and at the CDA Head Office Bulletin Board in the Main Lobby continuously for 29 days;

WHEREAS, the BAC also invited the representative/s from the Commission on Audit (COA), Procurement Service – Department of Budget and Management (PS-DBM), Philippine Chamber of Commerce & Industry (PCCI), and National Confederation of Cooperatives (NATCCO) to act as observers for the whole bidding procedures;

WHEREAS, the Pre-Bid Conference was conducted on **February 4, 2025** and was attended by four (4) prospective bidders, namely, 1) MAROONSTUDIOS, INC., and 2) GLOBE TELECOM, 3) MYBUSYBEE INC., and 4) E-PLDT;

WHEREAS, one (1) bidder, namely, **MAROONSTUDIOS, INC.**, bought the bidding documents and submitted their bid on or before the bid opening scheduled on **February 18, 2025**;

WHEREAS, the bid submitted by the following bidders were found to be substantially complying with respect to its technical and financial components, to wit:

WHEREAS, after careful examination and evaluation of the entire bid submitted by **MAROONSTUDIOS, INC.**, its bid was found to be responsive.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare the bid of **MAROONSTUDIOS, INC.**, with business address located at Unit 1218 12F, Corporate 145 Bldg. Mother Ignacia Ave. Quezon City, as the Single Calculated and Responsive Bid; and
- b) To recommend to the Head of the Procuring Entity of the Cooperative Development Authority that the contract for the **“PROCUREMENT OF ONE (1) YEAR SUBSCRIPTION OF CLOUD BASED ELECTRONIC MAIL SYSTEM FOR THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA) FOR THE YEAR 2025-2026”** WITH PROJECT ID NO. CDA-GOODS-2025-01 be awarded to **MAROONSTUDIOS, INC.**
